- 1) All deposits paid towards the sale of the kitten are **non-refundable.** If the buyer decides, under any circumstance, they no longer want to purchase the kitten on this sale agreement, or do not pick up the cat, the deposit will not be refunded.
- Seller agrees that the deposit paid goes towards the purchase of the above described cat. Buyer agrees that the price of each cat depends on the quality/colour of the cats and may differ with each cat/litter.
- 3) Seller may choose to deliver the cat at an extra cost. The buyer may also choose to have the cat shipped to them at their own expense.
- 4) Seller guarantees your bengal is purebred and TICA registered.
- 5) Seller has guaranteed the buyer that the kitten is in good health at the time of pick up. Both parents are FIV/FeLV and PRA/PK DEF negative.
- 6) The kitten is guaranteed against congenital defects for a period of 12 months after the date of birth.
- 7) Buyer agrees to have the kitten/cat examined by a licensed veterinarian of their choice within 72 hours of receiving their new Bengal kitten. The buyer is required to show proof of a licensed

veterinarian visit within 72 hours after the purchase and pick up of the kitten. A signed document from the licensed veterinarian stating that she/he has examined the kitten described above and has deemed the kitten to be in good health. This proof will be to be submitted to the seller within 72 hours after the purchase and pick up of the bengal kitten.

- 8) In the event the kitten is diagnosed by a licensed veterinarian with a hereditary or congenital defect that is detrimental to the cat's health, a proof must be presented to the seller. The kitten will be replaced with another kitten of equal value and quality, as available, at the discretion of the breeder. No cash refund will be given. Should the kitten pass away before diagnosis is made, a necropsy report would be required proving the death was caused by a congenital defect.
- 9) Buyer has been informed of the dangers of an outdoor environment and agrees to only let the kitten outside if it is leashed and accompanied by an adult.
- 10) Buyer agrees to spay/neuter the kitten before 12 months of age and understands once this is confirmed in writing by their licensed veterinarian, they will receive their TICA registration.
- 11) Buyer has been informed the kitten has been inoculated twice against panleukopenia, feline rhinotracheitis, calicivirus and chlamydiosis. The kitten also received 1 vaccine against rabies.



- 12) Buyer agrees to leave the kitten's claws intact. Trimming of the claws by a veterinarian, grooming salon, or the buyer to minimise damage to furniture is allowed and recommended. Buyer agrees that under no circumstances will the kitten/cat be declawed. In the event that the kitten/cat have been declawed, there will be no replacement or refund and the contract will be void.
- 13) Buyer agrees to feed the kitten the same food as the seller. If a change is necessary for any reason, the seller has been informed to change the food gradually over a 1-2 weeks period. Any sudden changes to a kitten's diet can be upsetting to their gastrointestinal system.
- 14) Buyer has been informed that it is recommended to slowly transition the kitten to its new home. Ideally, kittens should be placed in a smaller room by themselves along with their food, water and litter for 48 hours before allowing access to the rest of the home.
- 15) At the time of purchase and pick up of the kitten, the kitten will have its 1st and 2nd vaccines out of a 3 set series. Buyer is required to give the 3rd vaccine at their own cost.
- 16) The seller will guarantee fertility if being sold for breeding rights. If the cat is not able to produce a litter after 2 years of age, the seller will take the cat back and give the buyer an exchange of a cat of equal quality, and value, as available, at the discretion of the seller. Proof of attempt of breeding with a proven stud or queen, with documentation of a litter with that cat's name, will also need to be provided to the seller. The cost to deliver or ship the cat back to the seller will be at the buyer's expense.
